3. **Alterations** - Modifications and edits are billed at a rate of \$50/hour with a 1/2 hour minimum. All edits and modifications must be submitted no later than one month prior to your opening date.

4. **You shall not have the right to print, copy, arrange, adapt, or edit any of said musical compositions without the aid of, or permission from, The MT Pit. COPYING, RECORDING, OR TAMPERING WITH MACHINES OR THE SHOW AUDIO IS A VIOLATION OF CONTRACT AND WILL RESULT IN A \$1000 FINE AND POTENTIAL FEDERAL PROSECUTION. ALL SALES ARE FINAL.**
